- 1. **Welcome and introduction:** The SN sector coordinator welcomed the attendees and asked for a round table introduction.
- 2. Updates from the SN sector coordinator:
- Syrian Needs Assessment Tool (SYNAT): The coordinator provided an update on the ongoing Syrian Needs Assessment Tool, an inter-sectoral tool developed in response to the recent influx. The current status of the assessment is that enumerators (from 58 UNHCR and 2 NRC) are collecting data via Key Informant Interviews (KII)
- Tracking of Influx: The Area Humanitarian Coordination Team (AHCT) in Homs has implemented a
 tracking tool for newcomers (both Lebanese and Syrian) in response to the current emergency.
 The tracking of families is carried out through UNHCR community center ORVs, which provide
 detailed information on family destinations within communities. The tracking outcomes are
 shared weekly with sector members.
- Reporting: The coordinator reminded members to report their achievements through the
 ActivityInfo platform. Members who do not yet have access were encouraged to contact the sector
 team to be added.
- PSEA Session: A dedicated training session on Prevention of Sexual Exploitation and Abuse (PSEA)
 will be conducted for shelter sector members in Homs. It was agreed that November 20 would be
 a suitable date for the session.
- **3. Updates on the hosting centers:** Shelter SN Coordinator shared the latest figures of the hosting centers in Homs as follows:

HEKS-EPER requested an update on the figures for hosting centers and inquired about tracking new arrivals, noting the frequent movement of families in and out of the centers. This movement may lead to gaps in interventions, as some families may not be accurately reflected in the numbers. The sector advised coordination with the NFI and Protection sectors to address this issue, particularly for any distribution or protection activities.

Gaps Identified:

The sector highlighted the need for maintenance at the Mahmoud Othman hosting center and requested the provision of washing machines for the centers in Homs.
