Shelter Cluster Strategy

Shelter Cluster Strategy			
	<u>Current Situation</u>		
	After eleven years of conflict, 4.4 million people in North West Syria live in siege-like conditions where there are acute shelter needs:		
Situation	 2.2 million people need shelter assistance 800,000 people live in tents (90% of which are more than 1 year old). 1.7 million people live in 1,400 unplanned, self-settled IDP sites which lack access to services. 86% of sites are critically overcrowded. 58% of people living in IDP sites are children 40 % of people living in NW Syria have a disability (53% of in-camp households have 1 member with a disability). 548,000 people accessed GBV services in 2021. 		
	Poor quality basic shelter conditions, high rates of gender-based violence, and the impact of poor living conditions on children, the impact of climate change and natural disasters that make traditional approaches to shelter less effective.		
	Climate change means that recent winters have been extremely cold and wet with heavy snows, widespread flooding and sub-zero temperatures. Around 50% of current

cluster expenditure is therefore focussed on short term seasonal support to help people living in inadequate shelter to survive winter.

Dignified Shelter & Living Conditions

In this context, both shelter and protection actors have identified a need to move to a more adaptive and contextually suitable approach to humanitarian shelter. The Dignified Shelter & Living Conditions approach complements existing emergency response activities while identifying new shelter options for situations of protracted displacement.

Dignified Shelter & Living Conditions are more robust approaches to shelter and site improvement. The approach aims to upgrade unplanned self-settled IDP sites and promote inter-sectoral programming: Shelter, WASH, Early Recovery, Protection, and CCCM in particular.

UN Security Council Resolution

There is ongoing uncertainty around the renewal of the UN Security Council Resolution authorising Cross-Border assistance. This has the potential to affect around 50% of cluster funding. This, in turn, will disproportionately impact the work of local NGOs. Key cluster advocacy concerns the need to guarantee the continuation of existing funding levels as well as the more effective use of funds through the Dignified Shelter & Living Conditions approach. The cluster continues to invest in capacity development of cluster members to reduce make them less reliant on an unstable humanitarian system.

	Advocacy for investment in Dignified Shelter & Living Conditions.		
	The SNFI Cluster will continue to work closely with the following sectors (among others):		
Integrated Approach	 Protection Cluster: strengthening of HLP, including security of tenure, and with regard to the mainstreaming of gender and GBV-related issues in both the response and its monitoring; 		
	 CCCM Cluster: location and identification of camps, camp management services; WASH Cluster: emergency water and sanitation in managed camps and 		
	informal sites, essential water and sanitation services.		
	 Early Recovery & Livelihoods Cluster: site infrastructure, livelihoods, training, cash for work. 		
	 Cash Working Group: cash coordination, tracking and standard setting. HLP Working Group: production & revision of HLP due diligence guidance. 		
	Do No Harm: In a complex protracted conflict the cluster closely monitors the social, physical, and political impact of shelter interventions.		
Cluster Principles	Protection: Shelter provides the physical structures of protection. Shelter actors work closely with the Protection Cluster to address the needs of the most vulnerable, to understand the causes of vulnerability, and to ensure the centrality of protection analysis in shelter strategy, programming, decision-making, resource allocation and prioritisation.		
	Safety, Adequacy & Dignity: All shelter interventions need to meet minimum technical standards based on the principles of safety, adequacy and dignity. This guidance is developed by local organisation working with individuals, families, and communities living in NW Syria and in need of shelter assistance.		
	Empowerment of local actors: The SNFI Cluster empowers local humanitarian actors through brokering partnerships, inclusive leadership, funding advocacy, and investment in capacity development.		
	Effective use of aid funding/value for money: In a funding-constrained environment, the SNFI Cluster advocates for effective, appropriate, and adaptable funding to reduce reliance on costly, repeated short-term interventions. The Cluster advocates for a more effective use of aid money that is better suited to protracted displacement.		
	Inclusive programming: SNFI Cluster agencies work with individuals, families, and communities to ensure inclusiveness in humanitarian shelter programs. The Cluster understands and differentiates between the needs of women and men, boys and girls, people living with disabilities, the elderly, minority groups, and people with limited access to resources or low socio-economic status.		
	Climate Change & DRR: NW Syria experiences both conflict and even greater weather		

Accountability & Participation: The SNFI Cluster prioritises accountability to affected people and participation of communities in the design, development, monitoring, and

uncertainty (unpredictably harsh winters and summers) caused by climate change. The need for adaptation and disaster risk reduction within a conflict setting will be

integrated into humanitarian shelter programming.
