Coordination

- **2025 HNO/HRP:** Due to the inability to perform comprehensive shelter assessments or Multi-Sector Needs Assessments, the shelter sector will adhere to the previous year's method. This approach involves revising and updating the 2023 figures, considering updated population data and ongoing interventions. The validation process will use the Delphi methodology, leveraging expert opinions to evaluate the data. Additionally, the results will be cross verified with secondary data from partial evaluations conducted by the partners throughout 2024.
- **SHF 1st Standard Allocation:** The shelter sector collaborated with other sectors to determine priority sub-districts and funding allocations. The shelter and NFI sector have been allocated 3.5 million USD from the total allocation of 30 million USD. Additionally, in consultation with partners, the shelter sector identified activities that align with the two main strategic objectives of this allocation: providing basic services in underserved locations and strengthening resilience through service enhancement.

Response

- **Technical Guidelines:** Following several collaborative revisions by shelter partners and sub-national coordinators, four revised or newly developed technical guidelines for core shelter activities have been completed and submitted to the line ministry for review and feedback. These guidelines cover the following activities: minor repairs and rehabilitation of damaged houses, structural assessments, and repairs of structurally damaged buildings, and identifying the scope, limitation and counting for infrastructure repair.
- **Capacity Building:** During its mission to Deir Az-Zour, the shelter sector organized a comprehensive two-day capacity-building workshop for partners based in Deir Az-Zour, the majority of whom are national partners. The training covered topics such as the Humanitarian Program Cycle (HPC), coordination structures, and a discussion of shelter activities and their technical standards.

GAPS / CHALLENGES

- Significant economic decline coupled with price fluctuation has resulted in a decreasing scope and/or target for shelter projects.
- The diminishing coping capacities of both IDPs and host communities, along with limited financial resources of the government and sector partners, are leading to an increase in shelter need.

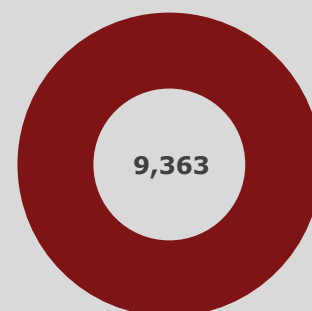

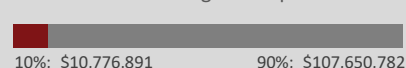

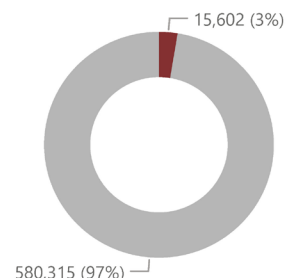

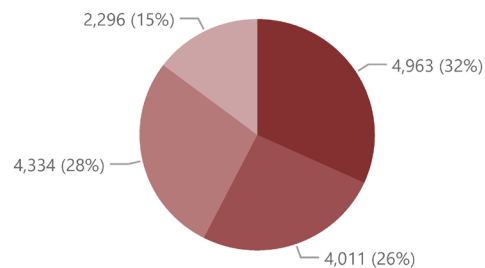

Total Individuals Reached



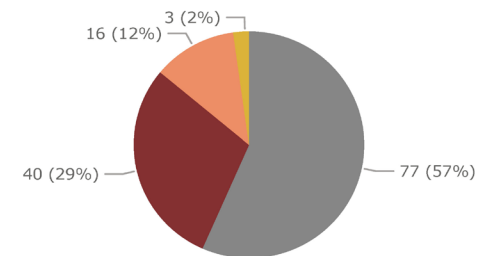

Total Individuals Reached by cohort



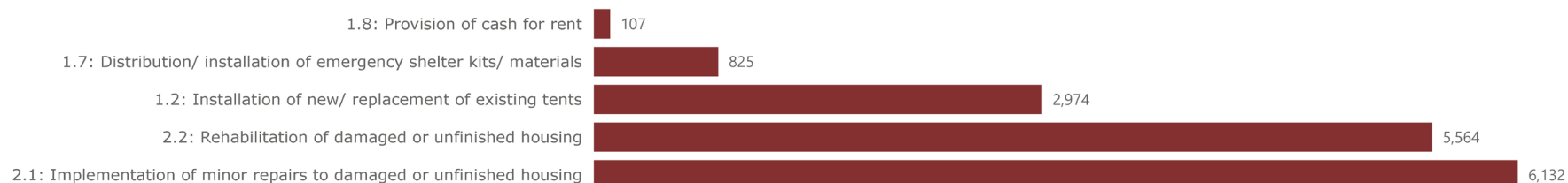

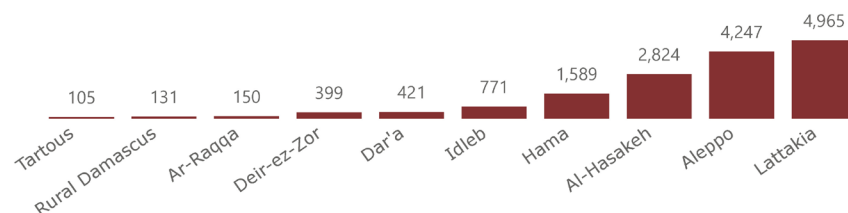

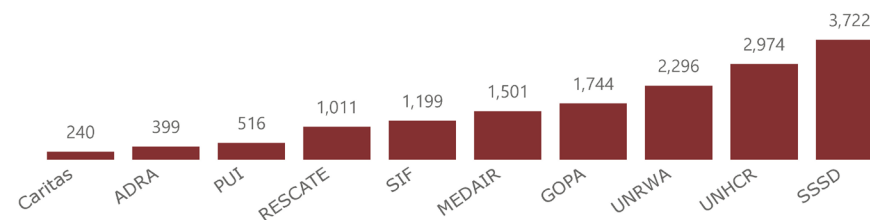
Individuals Reached Per Activity
