



2M People in Need





Key Challenges

The humanitarian crisis in Northwest Syria remains acute, with approximately 2.2 million people needing shelter assistance. Over 800,000 individuals, mostly women and children, live in tents and makeshift shelters that provide inadequate protection from harsh winter conditions.

- Inadequate Living Conditions: Most internally displaced persons (IDPs) inhabit old tents in sites lacking proper sewage, drainage, electricity, and water supply. Heavy snowfall, widespread flooding, and muddy roads worsen the already dire conditions in overcrowded camps.
- Winter Severity: Long, extremely cold, and unpredictable winters cause immense suffering for 2 million people lacking adequate shelter and heating.
- Health Risks: Winter months bring a surge in respiratory infections, resulting in higher rates of hospitalization, illness, and death, particularly among children and the elderly.

Situation Overview and Funding Update

As winter approaches, the vulnerable populations in Northwest Syria face severe challenges that threaten their survival and well-being. This advocacy note outlines the critical need for immediate and comprehensive winterization assistance to protect lives and alleviate suffering among displaced and host communities.

An estimated USD 65 million is needed to provide essential winter assistance to 1.4 million individuals and respond to winter-related emergencies.

Urgent Needs

To address these critical issues, we urgently require the following interventions:

- **Heating Fuel and Stoves:** Vital for providing warmth and preventing hypothermia.
- **Winter Clothing Kits:** Essential for protecting vulnerable populations from extreme cold.
- **Winterization Kits:** Including thermal blankets and carpets to enhance shelter insulation.
- **Flood Prevention and Mitigation:** Measures to safeguard shelters and camp infrastructure from damage.

Call to Action

We urgently appeal to donors and the international community to:

- Increase Funding: An estimated \$65 million is needed to provide essential winter assistance and respond to 1.4M people vulnerable to winter-related emergencies.
- Prioritize Winterization: Allocate resources to core winter assistance activities, crucial for survival during the harsh winter months.
- Support Long-term Solutions: Invest in more dignified and durable shelter options to reduce reliance on tents and makeshift structures.

Your immediate support is vital to protect the lives and dignity of vulnerable populations in Northwest Syria this winter. The approaching cold season poses a critical humanitarian challenge in the region. Swift and coordinated action is essential to shield vulnerable people from harsh winter conditions. We urge all stakeholders to prioritize winterization assistance as a life-saving intervention. Together, we can alleviate suffering and prevent unnecessary loss of life.

Winterization Response Strategy for Northwest Syria

Objectives

- Provide essential winter supplies to vulnerable populations
- Mitigate health risks associated with cold weather
- Reduce negative coping mechanisms
- Improve living conditions in IDP camps and informal settlements

Geographical Prioritization

The winterization response in Northwest Syria prioritizes:-

- Geographical Prioritization: The SNFI Cluster analyzes communities using a winterization severity index, scored from 1 (minimal) to 5 (critical). Indicators include elevation, temperature, snow impact, precipitation, IDP population proportion, NFI and shelter severity, heating fuel affordability, and flood vulnerability.
- The overall community severity level informs the Winter People in Need (PIN) calculation. The SNFI Cluster will prioritize high-severity communities, followed by moderate-severity communities (secondary priority) as identified by the Shelter NFI cluster analysis

Key Response Activities

Recommended life-saving cluster supplies for winter response include:

- 1. Heating fuel and stoves
- 2. Winter clothing kits
- 3. Winterization kits (including thermal blankets and carpets) The cash value of assistance for the above items is \$180

Infrastructure Improvements: Enhancing drainage systems and implementing flood prevention measures in camps

Population Prioritization

- Due to funding constraints, the S/NFI Cluster targets highly vulnerable households during cold winter periods. Winter increases respiratory infections, leading to higher hospitalization, morbidity, and mortality rates. Without adequate warmth and shelter, the risk of respiratory infections, hypothermia, and preventable deaths rises, especially for children and the elderly. The S/NFI Cluster has guidelines to identify highly vulnerable families, including female-headed households, households led by persons with disabilities or chronic illnesses, elderly-headed households (60+ years) without able-bodied adults, child-headed households, families with pregnant/lactating women or people with disabilities or severe chronic diseases, and households hosting orphans.
- This prioritization ensures that the most vulnerable populations in the hardest-hit areas receive timely and effective winterization assistance.

Implementation Approach

- Timely Response: Initiate winterization activities before the onset of cold weather
- Cash-Based Interventions: Prioritize cash and voucher assistance where markets are functional
- Coordination: Collaborate with other clusters (e.g., Health, WASH) for a comprehensive response
- Unique Cases and Referrals: Shelter NFI cluster members must work closely with the cluster coordination team to address unique cases. A referral system will ensure smooth, confidential registration for cases needing immediate response that may not meet standard criteria.
- Community Engagement: Involve affected populations in planning and implementation
- Monitoring and Evaluation: Conduct regular assessments to ensure effectiveness and adapt as needed

Monitoring and Reporting

Implement a robust monitoring system to track progress, including post-distribution monitoring and beneficiary feedback mechanisms. Regular reporting will inform stakeholders and guide response adjustments. The S/NFI Cluster has detailed reporting tools for tracking plans and progress of cluster members' projects.

Coordination


Monthly coordination meetings with implementing cluster members will address emerging issues and challenges, ensuring no duplication of assistance.

Key Challenges and Mitigation Measures

- Funding Gaps: Intensify advocacy efforts with donors and explore alternative funding sources
- Access Constraints: Coordinate with local authorities and partners to ensure safe humanitarian access
- Non-acceptance of Targeted Approach: Engage all key stakeholders throughout the project cycle, ensuring transparent communication of targeting criteria to the community
- Climate Unpredictability: Maintain flexibility in programming to respond to changing weather patterns




Geographical Target Breakdown by District
